Participant Portal

Participants or their authorized representative view, edit and approve visits and electronic timesheets. Timesheet data can be exported to the payroll system to complete the financial cycle. The portal provides information about the quantity of services authorized and services remaining in an easy to read dashboard.

Electronic Visit Verification

Employees have real time access to view and make corrections to visit data, view timesheets and manage time worked.

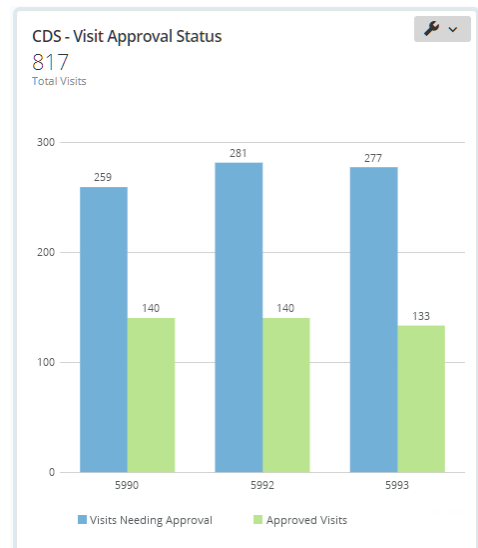
